Secretary's Report

Membership was asked if there were any corrections or additions to the May 15, 2024 General Meeting Minutes. Misspelled word House corrected.

Treasurer's Report

Report presented by Farchmin to Membership in attendance. A motion was made by Daluga, second by Porter to accept the Treasurer's report as read, subject to audit. Motion carried.

Committee Reports

DNR (weekly news update dnr.wi.gov)

Wincek attended a "round table" discussion with several Organizations and the DNR Assistant Secretary and DNR Staff in Madison on June 12, 2024. DNR reports there is a severe monetary deficit in their budget. DNR had to borrow \$14 million from Forestry Division to offset expenses. They asked for solutions to their budget issues. Recommended to have programs that will involve people in utilizing the outdoors. Example: Kids Fishing Clinic. Kids will get interested in the sport and parents will have to buy licenses to take their kids fishing.

Kids Fishing Clinic

Kids Fishing Clinic at Daniel Boone Conservation League on June 9, 2024 at 9am-1pm. There were 62 attendees – 48 were kids. WCCA, Great Lakes Sportsmen Fishing Club, Monches Fishing Club, WCCA and DBCL sponsored this event. 16 volunteers. We had hot dogs, chips and water for the kids in the Clubhouse. Kwik Trip in Lisbon gave us a substantial discount for the food. Plans are already in the works for next year in June.

Wisconsin Conservation Congress

- District Leadership Council will be meeting with NRB in June to discuss the DNR Spring Hearing questions and status of WCC approved Resolutions from public. One Resolution concerns the Commercial Fishing of Lake Michigan to take Lake Trout. The WCC recommends against Commercial Fishing of Lake Trout as per public input at Spring Hearing. Commercial Fishing Board does not believe the WCC report and will now try going through the WI Congress to pass the fishing of Lake Trout.
- He and Brenda Schaff met with Waukesha County Park/Rec Staff about all the restrictions they are
 placing on Clubs, etc. for using their ponds for Kids Fishing Clinics. County claims the DNR said they
 are not involved in Kids Fishing Clinics, yet the DNR is stocking fish in the County Parks. Contact
 then made with Bob Nack from DNR who stated he would reach out to Waukesha County Park/Rec.
- Wincek spoke about the Youth Conservation Congress and we need to get Club Mentors to involve our local youth. He could have Kyle Zenz come to a meeting to give details about the program.
- WCC Chairman is reorganizing the Members of the WCC Committees. Diedrich and Wincek will remain on their respective committees.
