Secretary's Report

Membership was asked if there were any corrections or additions to the November 13, 2024 General Meeting Minutes. Motion by Daluga, second by Gray to accept the Minutes as published. Motion carried. Minutes are always posted to the WCCA Website.

Treasurer's Report

Report presented by Farchmin to Membership in attendance. A motion was made by Gray, second by Daluga to accept the Treasurer's report, subject to audit. Motion carried.

- DBCL and Mapleton renewed their memberships.

Communications

Committee Reports

DNR (weekly news update dnr.wi.gov)

- DNR was investigating a small spill. Bigger number in an article. (2 gal. then 126 gal then 69,300 gal) Embridge is company responsible, but the spill is being cleaned up. Should not be an impact on the water table.
- CDAC proposed 2025 northern Forest Land deer hunting be divided by Zones not be County. DNR has agreed to this. Waiting on NRB and Governor.
- Virtual DNR Round Table meeting on Dec.16. which Wincek & Diedrich attended. Several items brought up.
 - a. Now claiming the budget is only a \$16 million deficit not \$26 million like first reported. DNR has some funding scenarios, but it can't be made up through fee changes .It was suggested a sales tax could be added to each property owner, so it wouldn't just be hunting and fishing supporters. DNR stated it would have to go through the NRB and the Legislature and they don't see that happening.
 - b. Governor selected a new Secretary, but won't release the name. (came out after meeting)

Wisconsin Conservation Congress

- Marine Wardens reduced to 8. They cover all the Wisconsin shorelines for Lake Michigan to Lake Superior. They also have to monitor the Commercial fishermen intake.

• Rules & Resolutions Committee is reviewing the WCC Code of Procedures and updating. 2 meetings before the District Leadership Council meets in January.

Hintz

- Migratory Committee meeting on Dec. 7. Reviewed 6 Resolutions and moved 2 forward.
- 2025 there will be a new 5-year plan decided for the 26-30 season..
- Looking into a Sandhill Crane Stamp to help the farmers.
- Committee reviewed having 4 fly zones. Vote ended in a tie so it failed.
- 60-day season with possible change in season dates.
- Hi-bred genetics study done. European ducks years ago and they have now integrated with North American European mallards are still being released by game farms in the eastern part of the US and one game farm in Wisconsin is still releasing European mallards. If the practice is stopped the poor genetics could be eliminated in approximately 2 years.
